Subject: Forfeited Property Items

Background

The Troy Police Department, Investigative Services Division, has forfeited property items seized in connection with narcotic investigations and arrests (Case Numbers 08-28524, 05-24770, 89-40073). The items forfeited included watches, rings, pendants and coins. Attempts were made to sell the jewelry items via the MITN website and eBay, but the overall interest was limited and minimum bids were not obtained. In an effort to maximize efficiencies, the Criminal Intelligence Unit of Troy Police Department, consulted with Purchasing Department personnel and obtained three bids from local jewelers. The jewelers included Tappers Diamonds & Fine Jewelry, Matt's Jewelry Brokers LLC, and Troy Jewelers, Inc. Those bids were sought with consideration to the projected sale prices and the cost of dedicated resources.


