- Consumers Energy Company proposes to reconcile gas revenue pursuant to its gas utility Pilot Revenue Decoupling Mechanism for the period June 1, 2010 through May 31, 2011, if the Michigan Public Service Commission approves its request.

PARTICIPATION: Any interested person may attend and participate. The hearing site is accessible, including handicapped parking. The Michigan Public Service Commission (Commission) will hold a public hearing to consider the September 1, 2011 application of Consumers Energy Company (Consumers Energy), which seeks approval to reconcile gas revenue pursuant to the natural gas utility Pilot Revenue Decoupling Mechanism (PRDM) for the period June 1, 2010 through May 31, 2011. Consumers Energy also seeks approval to adjust its existing retail gas rates to recover the amount of \$15,650,182, plus interest, in additional revenue.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to: mpscedockets@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by January 3, 2012. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon Consumers Energy's Legal Department - Regulatory Group, One Energy Plaza, Jackson, Michigan 49201.

Any person wishing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his/her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's website, and subject to disclosure.

Requests for adjournment must be made pursuant to the Commission's Rules of Practice and Procedure R 460.17315 and R 460.17335. Requests for further information on adjournment should be directed to (517) 241-6060.
