Subject: Standard Purchasing Resolution 4: State of Michigan – MiDEAL Program –
 Fleet Vehicles

Background

Bill Snethkamp – Dodge of Lansing is one of the awarded low bidders from the State of Michigan – MiDEAL Program – Contract #071B1300010. The Police patrol vehicle being purchased is a replacement vehicle for one sold at auction. By purchasing the Dodge Charger it will allow us to utilize most of the current Police equipment from the auctioned vehicle limiting additional upgrade expenses. The Dodge Charger is used daily for local, major and freeway patrols. The number of vehicles assigned to the Police department was reduced by thirteen vehicles over the past five years. Bill Snethkamp – Dodge notified us that he has several 2012 Dodge Charger Police vehicles meeting our specification for immediate delivery. The 2013 Dodge Police Charger purchase price is expected to increase \$700.00 to \$1,000.00 per unit.

Recommendation

City management request authorization to purchase one (1) 2012 Dodge Charger for the Police Department from Bill Snethkamp - Dodge of Lansing, MI, through the State of Michigan MiDEAL Program for an estimated total cost of \$22,598.00.
