SUBJECT: Final Reporting – Online Surplus Auction Sales – Police Department

Background

Resolution #2012-04-079-J4c approved the City's use of online auction websites to market specialty pieces of equipment as long as there was no cost to the City. After evaluating the various online auction services available, the Police department decided it was in the City's best interest to advertise on two different websites, eBay and MITN (the Michigan Inter-governmental Trade Network) for specialty police equipment.

A Canine Transport System was sold via eBay and purchased by another law enforcement agency for \$1,750.00. PVP Communications motorcycle microphones were originally offered for sale through MITN, but the sole bidder did not meet the reserve price. So, the bidder was contacted. It turns out the Rochester Police Department was the sole bidder, and agreed to pay the reserve price of \$1,250.00.

The sale of surplus property is a statutory requirement of the Purchasing Department. (Chapter 7, Sec 8)

Recommendation

This agenda item reports final results of miscellaneous 2012 auctions to City management. No action is required.


