**ITEM B – APPROVAL OF MINUTES OF MEETING OF OCTOBER 5, 2005**

**ITEM C – VISITORS, DELEGATIONS AND GENERAL PUBLIC**

Jeff Biegler, Superintendent of Parks & Recreation was in attendance to discuss playground structures. All current structures in Troy are accessible and meet or exceed the ADA guidelines. There are several parks in the planning stage that may be conducive to a boundless playground. Jeff thinks the boundless playground concept is a terrific idea but can be quite expensive. **ITEM E – REGULAR BUSINESS**

**ITEM F – OLD BUSINESS**

Committee members were given copies of Table 1106.1 from the Michigan Building Code. This table sets forth the required number of accessible parking spaces based on the total spaces provided. If Council approves a parking variance, the required accessible spaces may be reduced based on the total number of spaces approved. Since this table doesn't differentiate between building use, members are asked to consider building uses in which a higher percentage of accessible spaces would be needed.

The new suggestions for accommodating persons with disabilities at the voting precincts were incorporated into the Election Training Guide. Tonni Bartholomew, City Clerk, will address the accessibility issue again when the new HAVA laws are in effect in 2006.

**ITEM G - INFORMATIONAL ITEMS**

Troy Today had an article regarding a grant writing course being offered at the Library. However, it was already full but will be offered again in February, 2006.

Werpetinski submitted a question at two forums for all City Council Candidates on their stand on accessibility for Troy citizens and a boundless park. They all agreed to give their support.

**ITEM H – CITY COUNCIL MEETING**

Werpetinski attended the meeting discussing the Clawson 911 calls agreement and reports that it would not affect emergency services for Troy residents.

Werpetinski also reports that the agenda for the City Council meeting is not correct in listing the current members of our Committee.
