SUBJECT: **AGENDA ITEM** – Standard Purchasing Resolution 8: Best Value Award – Sale of Surplus Parcels

### **RECOMMENDATION**

On July 11, 2005, City Council authorized the Real Estate and Development Department in conjunction with the Purchasing Department to advertise by sealed bid the sale of ten (10) surplus City owned, real estate parcels. CC Resolution # 2005-07-334.

City management recommends awarding the sale of surplus parcels for a total of \$562,862.00 to the highest qualified bidders as outlined in the attached bid tabulation(s), which opened October 26, 2005, and are summarized below.

### **BACKGROUND AND FINDINGS**

A number of City owned real estate parcels have been identified as surplus parcels by the Real Estate and Development Department; 27 of these parcels (see attached map) have been appraised to establish a minimum sale price.

Ten parcels were authorized by City Council to be advertised for sealed bids at a minimum price, with six being bid in October, of which, four received qualifying bids. Two parcels, one located at Maple and John R and the other at Maple and Rochester did not receive any bids. Minimum bids are set at \$235,000.00 and \$20,000.00 respectively. Both parcels were re-bid on November 1, 2005.

### **SELECTION PROCESS**

The City reserves the right to award the bids to the highest responsible bidder(s) meeting specifications. Property and structures will be purchased in an "as is" condition. Bids were received from September 26, 2005 to October 26, 2005, at which time they were publicly opened at 10:00a.m.

### **SUMMARY**

City Council authorized the sealed bid sale of ten surplus parcels. Signage, newspaper ads, Internet (city web page), the Michigan Intergovernmental Trade Network (MITN), direct mail, and City cable were used to solicit bids.

### **BUDGET**

Funds from these sales will be disbursed to the Sale of Land – Capital Revenue Account #4010.4673.010





