Subject: **Agenda Item** – Standard Purchasing Resolution 1 – Award To Low Bidder – Installation of Street Trees

RECOMMENDATION

On October 25, 2005, sealed bid proposals were opened to furnish and install an estimated 2500 bare root Street Trees for residential Right-of-Way areas. After reviewing these proposals, City management recommends awarding the contract to the low bidder, Steele's Services of Rochester, MI, for an estimated cost of \$312,500.00 at unit prices contained in the attached bid tabulation. The contract will commence in late winter, early spring of 2005/2006, when trees are still dormant.

SUMMARY

The contract will be to furnish and install 2500 bare root trees between the sidewalk and curb in front of Troy homes. At no time will a monoculture be created by the new plantings. This planting is in response to the significant loss of ash tree from emerald ash borer.

BUDGET

Funds for these materials will be available through the Parks and Recreation Capital account #401780.7974.130 for Subdivision Improvements.
