SUBJECT: Standard Purchasing Resolution 4: Award – Oakland County Cooperative Purchasing Agreement – Fleet Vehicles

### Background:

- The Oakland County cooperative bid for Chevrolet, Pontiac and Chrysler Jeep vehicles were awarded to the low total bidder for each product; Buff Whelan Chevrolet, Red Holman Pontiac and Golling Chrysler Jeep Inc, respectively.
- The vehicles being purchased are replacement vehicles for those sold at auction.

Re: Award – Oakland County Cooperative Purchasing Agreement – Fleet Vehicles

**Legal Considerations:**

- The vehicles are used on a daily basis to assure proper and proactive Police and Public Works protection and services. (Goal I & V).
- The purchase of the Police and Public Works vehicles would assure the safety and welfare of citizens and businesses and also reduce the liability for the City. (Goal I).

**Options:**

- City management and the Public Works Fleet Division recommend awarding contracts to provide fleet vehicles from Buff Whelan Chevrolet, Red Holman Pontiac and Golling Chrysler Jeep Inc. through Oakland County Cooperative Purchasing Agreements at an estimated total cost of \$282,770.35, \$16,641.00 and \$43,011.00 respectively.
