**NOTICE OF HEARING

THE DETROIT EDISON COMPANY

- The Detroit Edison Company may reconcile its power supply cost recovery plan for the net underrecovery of \$50,890,282 including interest, from all of its power supply cost recovery customers for the 12-month period ending December 31, 2006, and its pension equalization mechanism for the overrecovery of \$20,821,666 from its customers for the 12-month period ending December 31, 2006, if the Michigan Public Service Commission approves its request.

PARTICIPATION: Any interested person may attend and participate. The hearing site is accessible, including handicapped parking. The Michigan Public Service Commission (Commission) will hold a public hearing to consider the March 30, 2007 application of The Detroit Edison Company (Detroit Edison) to reconcile its power supply cost recovery (PSCR) plan for the 12-month period ending December 31, 2006, and to reconcile its pension equalization mechanism (PEM) for the 12-month period ending December 31, 2006. Detroit Edison proposes to collect the underrecovery of

\$50,890,282 including interest, from all of its PSCR customers through the operation of the PSCR for the year 2007. Detroit Edison also proposes to refund an overrecovery of \$20,821,666 to its PEM customers for the 2006 PEM reconciliation period.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets Website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to mpscefilecases@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by May 3, 2007. (Residential customers may file petitions to intervene using the traditional paper format.) The proof of service shall indicate service upon Detroit Edison's attorney, Jon P. Christinidis, 2000 Second Avenue, Detroit, MI 48226-1279.

Any person wishing to make a statement of position without becoming a party to the case, may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's Web site, and subject to disclosure.
