A public hearing has been scheduled for City Council to review the following liquor license violation:

Licensee Name: H-MART TROY, LLC
Address: 2963 E. Big Beaver Rd., Troy, Michigan 48083
License No: 224253-2013
Violation: SALE TO MINOR (Compliance Test) on March 4, 2014

Under Michigan law, three or more violations in a twelve month period COULD serve as a basis for City Council to request the Michigan Liquor Control Commission revoke an off-premises liquor license. An off-premises license allows alcohol to be purchased for consumption off site, which is distinguished from an on-premises liquor license, where alcohol is served at the licensed establishment/ restaurant.

By scheduling liquor hearings for those licensees that have violations during the preceding year, City Council has the ability to inquire about proactive measures that the licensee has taken or is willing to take to avoid future liquor license violations. If City Council finds that there was a violation during the past year, and Council is also concerned that the liquor licensee is likely to have continued liquor violations, then state law provides a process to revoke the liquor license. Prior to taking any adverse action, however, City Council must hold a public hearing and allow the licensee to come forward with any proactive measures that it has taken to guard against future liquor license violations. The public hearing also allows any neighbors of the licensee to voice their concerns to the City Council.

A copy of the reports documenting the alleged liquor law violations is attached to this memo, as well as the liquor licensee's history. Upon information and belief, the licensee is not contesting the liquor law violation, and an adversarial public hearing will not be required. However, City Council will need to officially open the public hearing and make a record of the violation. City Council will also need to offer the licensee an opportunity to comment, and also to entertain the comments of members of the public. At the conclusion of the comments, City Council may wish to require some proactive measures to guard against future violations. Based on the liquor licensee's past history, City Administration has prepared a resolution for City Council consideration that acknowledges the violation and requires the licensee's employees who sell alcohol to obtain training within 90 days.

<p>On 3/4/2014 at 1635hrs, DPU Officers were conducting LCC checks with minor decoy . identification was confiscated and held for safe keeping by the Troy Police Department.</p> <p>At approximately 1639hrs, decoy entered into H-Mart located at 2963 E Big Beaver in Troy. After entering the supermarket selected a bottle of OB Beer from the liquor aisle. entered into the cashier line and purchased the bottle of OB beer from an older Asian male. The Asian cashier is identified as Myong Sun Pak (3/25/58). At no time did cashier Pak ask Decoy for his identification or age. After the purchase, decoy exited the store and met up with DPU officers and handed the purchased beer over to Officer Stopczynski.</p> <p>DPU Officer's made the location and spoke with Manager Seong Yoon and cashier Pak. Manger Yoon was advised by officers of the above listed violation of the Michigan Liquor Control Commission. Cashier Pak was informed of the civil infraction he committed and was issued citation#14TR01621 for furnishing/sale to a person under 21/fail to inquire of age. Officers retained the sales receipt of \$2.64 for the beer and later turned it over to Troy property as evidence. The OB Beer was destroyed per department policy. Violation report to be submitted to LCC.</p> <p>No further action taken.</p>



CHARGE – MARCH 4, 2014

- (1) Sold or furnished alcoholic liquor to unnamed minor, Decoy, date of birth August 31, 1996, who was less than twenty-one (21) years old, contrary to Const 1963, art 4§ 40 and contrary to Section 801(2) and/or Section 701 (1) of the Michigan Liquor Control Code, MCL 436.1801(2) and/or MCL 436.1701(1).

FINDINGS OF FACT

The Commissioner finds as fact, based upon the signature on the Michigan Liquor Control Commission's (MLCC) Waiver and Acknowledgment form of Ilyeon Kwon, a member of the above-named Licensed Limited Liability Company, that under administrative rule R 436.1907 of the Michigan Administrative Code, the Licensee in this case has voluntarily waived the right to a hearing to contest the cited allegation in this matter and has entered a plea of acknowledgment to the one charge stated in Case No. 4-164024.

The Commissioner accepts the Violation Report of this case, along with any attachments therein, and a True Copy of the prior record of this Licensee at the above-named location as evidence in lieu of testimony in this matter.

The Commissioner believes and finds as fact, based on the Violation Report and attachments therein, that minor Decoy . . . while under the direction of the Troy Police Department, entered the above-named licensed establishment on March 4, 2014, and purchased alcoholic liquor from an employee of the above-named Licensee without showing proper proof of age.

The Commissioner further finds that the employee of the above-named Licensee in this case did not ask for identification, was not shown proper proof of age, and did not make a diligent inquiry to determine the proper true age of the purchaser.

The Commissioner further believes and finds as fact, based on the Violation Report and attachments therein, that at the time of this incident, minor Decoy i, born August 31, 1996, was 17 years of age.

Based upon the aforementioned Findings of Fact, the Commissioner concludes that the Licensee in Case No. 4-164024 did violate MCL 436.1801(2) of the Michigan Liquor Control Code, as cited.

ORDER

In determining this violation's penalty, the Commissioner considered the Licensee's total record at the above-named location, which shows no prior violations since securing MLCC licensure on April 23, 2013.

Therefore, the Commissioner Orders a penalty fine of \$600 for the charge in this matter. The Commissioner further Orders the Licensee to serve a suspension of thirty (30) continuous days, to run consecutively and not concurrently with any other suspension


