A presentation of the program was made by:

It was noted that this is a financing alternative for energy saving building improvements. Public Act 270 of 2010 allows Governmental entities to manage a PACE program. The concept is that savings from utilities will generate cash flow to pay principal and interest on loan proceeds. A contractor must guarantee the energy savings and be bonded to do as such. The loans for improvements are secured through a special assessment on the property which creates a lien on the property. The governmental entity has the option of assessing and collecting the repayment proceeds directly or they can option to have the lender collect directly. If the building is sold prior to repayment of the loan, the assessment transfers to the new owner.
