SUBJECT: Liquor Violation Hearing - 2Booli Restaurant

On February 19, 2015, the Troy Police Department conducted underage decoy inspections for liquor licensed establishments in the City of Troy. The team went to 2Booli, a restaurant located at 854 E. Big Beaver Road, where an underage minor decoy was served a draft beer. The person who served the beer to the minor pled responsible to the charge of *furnishing, sale to person under 21*, and was fined \$100 on March 24, 2015. A copy of the reports documenting the alleged violation is attached to this memo as well as a copy of the licensee's history.

2Booli has a Class C liquor license which means alcohol is served to patrons for consumption on the premises. Under MCL 436.1501, on premises liquor licenses are automatically renewed on a yearly basis unless the local legislative body (City Council) objects to renewal on or before March 30 of each year. A liquor license violation, such as the sale of alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license, as the possession of a Class C license is a privilege. Prior to taking any adverse action, the licensee is entitled to a due process hearing which provides the licensee an opportunity to challenge the violation and allows the licensee to come forward with any proactive measures that have been taken to guard against future liquor license violations. In the due process hearing, the City has the obligation to prove that there was a violation. The liquor violation hearing is scheduled in advance, with notice sent by mail to the licensee.

It should be noted that the licensee acknowledged the violation and waived the right to a hearing at the Michigan Liquor Control Commission (MLCC) which imposed a \$500 fine.

I (Sergeant Gobler) was working an underage decoy operation checking for liquor violations at businesses in the City of Troy. I escorted Decoy [redacted] as he attempted to make purchases at license facilities. Decoy [redacted] is 18 years of age and was not in possession of identification during the detail.

Purchase of Alcohol

02/20/2015 at 1620, Decoy [redacted] entered the 2Booli Restaurant at 854 E Big Beaver. Decoy [redacted] sat at a high top table near the bar and was met by server Christina Scrapa. Decoy [redacted] ordered a Bud Light draft from Scrapa. Scrapa did not request identification from Decoy [redacted] or inquire about his age. Scrapa attempted to pour a draft Bud Light but tap was empty. Scrapa returned to speak with Decoy [redacted] and he ordered a Labatt draft in place of the Bud Light. Scrapa poured a Labatt and served it to Decoy [redacted]. Decoy [redacted] contacted me by phone and asked me to enter the restaurant. I observed Decoy [redacted] seated with a draft beer in front of him. Decoy [redacted] identified the server as "Christina" and pointed her out to me. I asked Decoy [redacted] to leave the establishment. I contacted Scrapa and advised her that she had served alcohol to a minor. I asked Scrapa to contact a manager and have him respond to speak with me. The manager on duty was identified as Michael Tibbals. Tibbals retrieved the liquor license and presented it to me.

Interview with Scrapa

Scrapa was visibly upset and did not deny serving Decoy [redacted]. Scrapa declined to complete a written statement.

Evidence

A receipt for the Labatt was printed by Tibbals. The total sale was \$4.19. I also photographed the beer as it sat on the table in the establishment. These items were tagged and turned over to the property section.

Disposition

Scrapa was issued citation #15TR01842 for sold/furnished alcoholic liquor to a minor and was released with the citation. LCC violation paperwork was completed and will be submitted to LCC.





FINDINGS OF FACT

The Commissioner finds as fact, based upon the signature on the Michigan Liquor Control Commission's (MLCC) Waiver and Acknowledgment form of Lewis Ansara, Vice-President of the above-named Licensed Corporation, that under administrative rule R 436.1907 of the Michigan Administrative Code, the Licensee in this case has voluntarily waived the right to a hearing to contest the cited allegation in this matter and has entered a plea of acknowledgment to the one charge stated in Case No. 5-170516.

The Commissioner accepts the Violation Report of this case, along with any attachments therein, and a True Copy of the prior record of this Licensee at the above-named location as evidence in lieu of testimony in this matter.

The Commissioner believes and finds as fact, based on the Violation Report and

attachments therein, that minor Deco _____ while under the direction of the Troy Police Department, entered the above-named licensed establishment on February 20, 2015, and purchased alcoholic liquor from an employee of the above-named Licensee without showing proper proof of age.

The Commissioner further finds that the employee of the above-named Licensee in this case did not ask for identification, was not shown proper proof of age, and did not make a diligent inquiry to determine the proper true age of the purchaser.

The Commissioner further believes and finds as fact, based on the Violation Report and attachments therein, that at the time of this incident, minor Deco _____, born April 14, 1996, was 18 years of age.

CONCLUSIONS OF LAW

Based upon the aforementioned Findings of Fact, the Commissioner concludes that the Licensee in Case No. 5-170516 did violate MCL 436.1801(2) of the Michigan Liquor Control Code, as cited.

ORDER

In determining this violation's penalty, the Commissioner considered the Licensee's total record at the above-named location, which shows one prior dissimilar violation since securing MLCC licensure on April 17, 2012.

Therefore, the Commissioner Orders a penalty fine of \$500 for the charge in this matter. The Commissioner further Orders the Licensee to serve a suspension of twenty-five (25) continuous days, to run consecutively and not concurrently with any other
