SUBJECT: Liquor Violation Hearing – Maggiano's Little Italy

On February 25, 2015, the Troy Police Department conducted underage decoy inspections for liquor licensed establishments in the City of Troy. The team went to Maggiano's Little Italy, a restaurant located at 2089 W. Big Beaver Road, where an underage minor decoy was served a sample of beer in a plastic cup. The person who served the beer to the minor pled responsible to the charge of *furnishing, sale to person under 21*, and was fined \$100 on March 4, 2015. A copy of the reports documenting the alleged violation is attached to this memo as well as a copy of the licensee's history.

Maggiano's Little Italy has a Class C liquor license which means alcohol is served to patrons for consumption on the premises. Under MCL 436.1501, on premises liquor licenses are automatically renewed on a yearly basis unless the local legislative body (City Council) objects on or before March 30 of each year. A liquor license violation, such as furnishing alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license, as the possession of Class C license is a privilege. The licensee is entitled to a due process hearing which provides the licensee an opportunity to challenge the violation. In the due process hearing, the City has the obligation to prove that there was a violation. The liquor violation hearing is scheduled in advance, with notice sent by mail to the licensee.

It should be noted that the licensee acknowledged the violation and stipulated to a negotiated settlement in lieu of pursuing a hearing at the Michigan Liquor Control Commission (MLCC) which imposed a \$700 fine.

Narrative:

On February 25, 2015 the Directed Patrol Unit conducted Liquor Control Commission



compliance checks using minor decoys. The driver's license for each decoy was kept inside of the Troy Police Department for the duration of this assignment.

At approximately 1828 decoy [REDACTED] went into Maggiano's Little Italy restaurant located at 2089 West Big Beaver Road and sat down at the bar. [REDACTED] asked the bartender, later identified as Ms. Lori Mc-Coniga, for a Griffin Claw beer. Mc-Coniga offered to give [REDACTED] a sample of the beer and gave him a plastic cup of the beer. (The volume of the beer was approximately the size of a shot glass). Mc-Coniga served the beer without asking for the decoy's identification.

After I entered the restaurant, [REDACTED] identified Mc-Coniga as the bartender who had served him alcohol. I then advised Mc-Coniga that a violation had occurred. When I informed the general manager, Mr. Eric Batson, of the violation, he immediately terminated Mc-Coniga. I also advised Mc-Coniga that a ticket would be sent to her via certified mail. Mc-Coniga was issued citation 15TR02042 for Furnishing, Sale To Persons Under 21 And/Or Failure To Inquire As To Age During Enforcement Action. The ticket was mailed to Mc-Coniga's home address.

Since Mc-Coniga insisted that the beer was only a sample, no receipt was generated.

I completed a violation report, which will be forwarded to the Michigan Liquor Control Commission.

No further action was taken.

- (1) Sold or furnished alcoholic liquor to unnamed minor, [REDACTED] date of birth May 5, 1996, who was less than twenty-one (21) years old, contrary to Const 1963, art 4, § 40 and contrary to Section 801(2) and/or Section 701(1) of the Michigan Liquor Control Code, MCL 436.1801(2) and/or MCL 436.1701(1).

NEGOTIATED SETTLEMENT

On or about June 25, 2015, the parties filed a Stipulation for Negotiated Settlement for the Administrative Law Judge to consider in Case No. 5-170524. The stipulation was signed by Assistant Attorney General Susan Moody-Frezza, who represented the Michigan Liquor Control Commission (Commission) in this matter, and by Attorney John B. Carlin, Jr. on behalf of the above-named Licensee. The Administrative Law Judge has reviewed the terms and conditions of the stipulation in this matter.

ORDER

It Is Ordered that:

1. The Licensee's plea of acknowledgment to the sole charge as cited in the complaint is accepted by the Administrative Law Judge;
2. The Violation Report and its attachments are entered into the hearing record as substantive evidence;

3. The Administrative Law Judge will take notice of the prior record of this Licensee, since being licensed on September 20, 2004, at the above-named location under the current ownership;
4. The Licensee violated MCL 436.1801(2) as cited in the complaint;
5. As a penalty, the Licensee will pay a fine of \$700 for the one charge;
6. A suspension of thirty-five (35) continuous days shall be imposed if the fine is not paid, with this suspension to run consecutively and not concurrently with any other suspension Ordered by the Commission, if the fine is not paid within forty-five (45) days from the mailing date of this Order; and
7. This Negotiated Settlement is a full and final disposition of this matter before the Commission, that there is no further right of administrative or judicial appeal, either to the Commission or any court of law, that the plea in this case has been entered voluntarily and with the full understanding of all consequences, that there are no promises, stipulations, understandings or agreements other than those stated as part of the official record herein, and that this Negotiated Settlement represents the final agreed settlement.


