SUBJECT: Liquor Violation Hearing – A&S Babi, Inc. d/b/a John's Party Store

On February 20, 2015, the Troy Police Department conducted underage decoy inspections for liquor licensed establishments in the City of Troy. The team went to John's Party Store located at 4009 Livernois where an underage minor decoy was sold a six-pack of beer. The person who sold the beer to the minor pled responsible to the charge of *furnishing, sale to person under 21*, and was fined \$100 on March 4, 2015. A copy of the reports documenting the alleged violation is attached to this memo as well as a copy of the licensee's history.

John's Party Store has SDD and SDM liquor licenses which means alcohol is sold to patrons for consumption off the premises. Under Michigan law, a local unit of government may request, by resolution, that the MLCC revoke the license of an off-premises licensee if the licensee has sold or furnished alcohol to a minor on at least three separate occasions in a consecutive twelve month period. A liquor license violation, such as the sale of alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license if there are three or more such violations in a consecutive twelve month period, as the possession of SDD and SDM liquor licenses is a privilege. Prior to taking any adverse action, the licensee is entitled to a due process hearing which provides the licensee an opportunity to challenge the violation and allows the licensee to come forward with any proactive measures it has taken to guard against future liquor license violations. In the due process hearing, the City has the obligation to prove that there was a violation. The liquor violation hearing is scheduled in advance, with notice sent by mail to the licensee.

It should be noted that the licensee acknowledged the violation, and the Michigan Liquor Control Commission (MLCC) imposed a \$500 fine. The subject violation is the only one for John's Party Store in the calendar year 2015.

The licensee for John's Party Store contacted the City Attorney's office seeking an adjournment of the scheduled public hearing. Due to the notices having already been sent to interested persons in the area, it was not possible to adjourn the public hearing in advance. The public hearing should be opened and if there are members of the public with a desire to comment on the allegations, they should be given an opportunity to speak. Instead of closing the public hearing, Council may want to move to then postpone the item until March 14, 2016 at 6:00 pm to provide the licensee an opportunity to address Council.

Narrative:

On February 20, 2015 the Directed Patrol Unit was conducting Liquor Control Commission



checks with minor decoy [REDACTED] his driver's license was stored inside of the Troy Police Department for the duration of this assignment.

At approximately 1730 [REDACTED] entered John's Party Store & Pizza located at 4009 Livernois and selected a six-pack of Bud Light beer. [REDACTED] went to the counter and paid the lone employee, later identified as Mr. Adel Babi, for the beer. Babi later informed me that he is the business owner. Babi did not ask for identification when [REDACTED] paid for the beer.

After [REDACTED] left the party store and turned the beer over to me, I contacted Babi and advised him of the violation. Babi was issued citation 15TR01846 for Furnishing, Sale To Persons Under 21 And/Or Failure To Inquire As To Age During Enforcement Action.

The \$7.99 beer receipt was tagged as evidence and placed into property. I took a photo of the beer, which was also tagged as evidence and placed into property. The beer was disposed of. The audio recording of the violation will be uploaded into CLEAR. I completed a violation report which will be forwarded to the Michigan Liquor Control Commission.

No further action was taken.



- (1) Sold or furnished alcoholic liquor to unnamed minor, _____, date of birth May 5, 1996, who was less than twenty-one (21) years old, contrary to Const 1963, art 4, § 40 and contrary to Section 801(2) and/or Section 701(1) of the Michigan Liquor Control Code, MCL 436.1801(2) and/or MCL 436.1701(1).

FINDINGS OF FACT

Sana Thomas Babi, an officer of the above-named corporation, appeared before this Administrative Law Judge. After being advised of the constitutional right to be represented by an attorney pursuant to Rule 436.1909(2), Ms. Babi waived the right to legal counsel and entered a plea of acknowledgment to the one charge cited in Case No. 5-170521 pursuant to Section 903 of the Michigan Liquor Control Code, MCL 436.1903, and Rule 436.1909(1) of the Michigan Liquor Control Commission (Commission). Assistant Attorney General Susan Moody-Frezza represented all law enforcement agencies involved in this matter.

The Administrative Law Judge accepted said plea of acknowledgment after being assured that it was entered voluntarily and with the full understanding of its meaning and

implications. The Violation Report and its attachments were admitted into evidence as State's Exhibit 1.

The Administrative Law Judge finds that, while under the direction of law enforcement, Decoy _____ who was eighteen (18) years of age at the time of the incident, entered the above-named licensed establishment on February 20, 2015 and purchased alcoholic liquor from an employee of the Licensee. The Administrative Law Judge further finds that the employee of the Licensee neither demanded nor was shown proper identification showing that the decoy was at least twenty-one (21) years old; however, the employee still sold alcoholic liquor to the decoy. The employee did not make a diligent inquiry to determine the true age of the purchaser.

CONCLUSIONS OF LAW

Based upon the aforementioned plea and findings of fact, the Administrative Law Judge concludes that the Licensee violated MCL 436.1801(2) as cited in the one charge in the complaint in this matter.

ORDER

In determining penalty, the Administrative Law Judge considered the Licensee's total record, which shows three (3) previous violations since being licensed on December 12, 1995, at the above-named location under the current ownership.

As a penalty, the Administrative Law Judge Orders a fine of \$500 in this matter. Further, the Administrative Law Judge Orders that a suspension of twenty-five (25) continuous days shall be imposed if the fine is not paid, with this suspension to run

consecutively and not concurrently with any other suspension Ordered by the Commission, if the fine is not paid within forty-five (45) days from the mailing of this Order.

Further, the Administrative Law Judge Orders the Licensee to pay total cost of \$7.87 for witness fees involved in connection with the hearing.


