SUBJECT: Liquor Violation Hearing – California Pizza Kitchen

---

On February 25, 2015, the Troy Police Department conducted underage decoy inspections for liquor licensed establishments in the City of Troy. The team went to California Pizza Kitchen, a restaurant located at 2800 W. Big Beaver Road at Somerset Mall, where an underage minor decoy was served a draft beer. The person who served the alcoholic drink to the minor pled responsible to the charge of *furnishing, sale to person under 21*, and was fined \$100 on March 4, 2015. A copy of the reports documenting the alleged violation is attached to this memo as well as a copy of the licensee's history.

California Pizza Kitchen has a Class C liquor license which means alcohol is served to patrons for consumption on the premises. Under MCL 436.1501, on premises liquor licenses are automatically renewed on a yearly basis unless the local legislative body (City Council) objects on or before March 30 of each year. A liquor license violation, such as the sale of alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license, as the possession of Class C license is a privilege. The licensee is entitled to a due process hearing which provides the licensee an opportunity to challenge the violation. In the due process hearing, the City has the obligation to prove that there was a violation. The liquor violation hearing is scheduled in advance, with notice sent by certified mail to the licensee.

It should be noted that the licensee entered a plea of acknowledgement to the violation and entered into a negotiated settlement with the Michigan Liquor Control Commission (MLCC) which ordered the licensee to pay a \$500 fine.

**Narrative:**

On February 25, 2015 the Directed Patrol Unit conducted Liquor Control Commission compliance checks using minor decoys. The driver's license for each decoy was kept inside of the Troy Police Department for the duration of this assignment.

At approximately 1639 decoy [redacted] went into the California Pizza Kitchen inside of the Somerset Collection located at 2800 West Big Beaver Road. [redacted] sat at the bar and ordered a draft beer from the bartender, later identified as Mr. Kyle Deschaepmeester. After Deschaepmeester served the beer to the decoy without checking his identification, I entered the bar at which point [redacted] identified the bartender who had served him.

Both Deschaepmeester and the general manager, Mr. Mike Howell, were advised that a violation had occurred. I also advised Deschaepmeester that he would be receiving a ticket via certified mail. The draft beer was left at the restaurant. Deschaepmeester was issued citation 15TR02038 for Furnishing, Sale To Persons Under 21 And/Or Failure To Inquire As To Age During Enforcement Action. The ticket was mailed to Deschaepmeester's home address.

The receipt of the sale was tagged as evidence and placed into property.

I completed a violation report, which will be forwarded to the Michigan Liquor Control Commission.

No further action was taken.

**CHARGES** - FEBRUARY 25, 2015

- (1) Sold or furnished alcoholic liquor to unnamed minor, [redacted] date of birth May 5, 1996, who was less than twenty-one (21) years old, contrary to Const 1963, art 4, § 40 and contrary to Section 801(2) and/or Section 701(1) of the Michigan Liquor Control Code, MCL 436.1801(2) and/or MCL 436.1701(1).

**NEGOTIATED SETTLEMENT**

The Commissioner has before him, a written Stipulated Agreement in the matter of Complaint No. 5-170525, California Pizza Kitchen, INC., the above-named licensee. The stipulated settlement was signed by Susan Moody-Frezza, Assistant Attorney General who represented all law enforcement in this matter, and J. Patrick Howe, Attorney for the Licensee.

Having reviewed the stipulated settlement in all its terms, the Commissioner accepts the settlement as stated and incorporates by reference the signed document of Case No. 5-170525.

The Commissioner, therefore, issues this:

**ORDER**

- (1) The Commissioner accepts the Licensee's plea of acknowledgment to the single charge, cited above;

(2) The Violation Report of this case, the Stipulated Agreement and the balance of the Michigan Liquor Control Commission (Commission) file in this matter are entered into the record as substantive evidence;

(3) The Commissioner further has taken notice of the prior record of this Licensee, which shows no prior violations since securing Commission licensure on April 23, 2012, at the above-named location under the current ownership;

(4) The Licensee is hereby Ordered to pay the sanction of a fine of \$500 for the one acknowledged charge, cited above, as penalty;

(5) The Licensee violated MCL 436.1801(2), as cited in the complaint in this matter;


(6) The Commissioner further Orders a suspension of twenty-five (25) continuous days if the total fine of \$500 is not paid within forty-five (45) days from the mailing date of this Order. This suspension, if served, shall run consecutively and not concurrently with any other suspension ordered by the Commission for this Licensee;

(7) The Commissioner also finds that Investigator Officer Gregory Stopczynski, of the Troy Police Department, has been consulted and has agreed with the terms of this Negotiated Settlement; and

(8) The Licensee agrees that this Negotiated Settlement was a full and final disposition of this matter before the Commission. The Licensee recognizes that, as to this complaint, there is no further right of administrative or judicial appeal; to either the Commission or a court of law. The Licensee also agrees that the plea in this case was entered voluntarily

and with the full understanding of all consequences. Furthermore, all parties agree that there are no promises, stipulations, understandings or agreements other than those stated above as part of the official record. This document represents the final agreed settlement.
