3. HEARING OF CASE

- A. **VARIANCE REQUEST, CHRISTIAN E. TAZZIA FOR CONTROLLED POWER COMPANY, 1955 STEPHENSON** – A variance to install a stairway chairlift resulting in a 33.75 inch stairway width and a handrail on only one side of the stairway. Section 1009.4 requires a 44 inch minimum width and Section 1009.15 requires handrails on both sides. - **2012 MICHIGAN BUILDING CODE**

Mr. Grusnick clarified for the record the required stairway width for a 50 or less occupancy load is 36 inches; therefore the variance request before the Board is for a 2.25 inch reduction in the width of the stairway.
