4. PUBLIC COMMENTS – Items not on the Agenda

SPECIAL USE REQUEST

5. PUBLIC HEARING – SPECIAL USE REQUEST (SU 354) – Proposed Somerset Pontiac Outdoor Storage of New Vehicles, North side of Maplelawn, West of Crooks Road (1728 Maplelawn), Section 29 – Zoned M-1 (Light Industrial) District

Mr. Savidant presented a summary of the Planning Department report on the proposed special use request, and reported it is the recommendation of City Management to approve the application with two conditions: (1) that any exterior lighting shall be designed so as to not negatively impact adjoining properties and (2) to replace the proposed 6-foot high wood screen fence with a 6-foot high screen wall.

Jack Fowler and Charles LeFevre were present to represent the petitioner.

Chair Schultz advised the petitioner that five (5) affirmative votes are required for a recommendation of approval of the special use approval, and the petitioner has the option to postpone the item at this time.

Messrs. Fowler and LeFevre indicated they would like to go forward with the item.
