The waitress, identified as Christin Vanderham, never asked \_\_\_\_\_ for any identification or what his d.o.b. or age was. Vanderham returned with a 16 oz glass of Amstel Light and served it to \_\_\_\_\_.

Student Enforcement Aide \_\_\_\_\_ returned to officers location and advised us that \_\_\_\_\_ had been served. Officer Daniels and I entered the business and spoke to \_\_\_\_\_ he pointed to Vanderham and advised officers that she was the waitress that served him.

Officers explained the situation to Vanderham and issued a citation to her for "Fail to Inquire As To Age." (citation number 717508) We gathered the required license information to complete an L.C.C. violation report and advised Manager Tim Wendt what would be required by the business. Officer Daniels advised Wendt that we needed to confiscate the beer. Officer Daniels observed Wendt pouring the beer into a white styrofoam cup. Officer Daniels then confiscated the beer.




