Report Narrative 07-32166

At approximately 1830 on 08-23-07, student enforcement aide \_\_\_\_\_ entered Red Robin Restaurant at 5460 Corporate to perform a liquor compliance check. I entered the restaurant shortly after \_\_\_\_\_. I observed that \_\_\_\_\_ had been seated in a two person booth to the north of the hostess stand. I watched \_\_\_\_\_ from the waiting area near the hostess stand and from north of the bar. \_\_\_\_\_ sat at her table for a few minutes before I observed server Jorge Albor-Mata approach her table. It appeared that they had a short conversation and then Albor-Mata walked back toward other wait staff standing near the food preparation area. A short time later I observed \_\_\_\_\_ serve \_\_\_\_\_ a 12 oz. bottle of Bud Light beer. \_\_\_\_\_ then walked to the food preparation area and began talking to server Albor-Mata. I then approached both subjects and identified myself as a City of Troy police officer. \_\_\_\_\_ then left the restaurant. \_\_\_\_\_ completed a written statement (see attached).

I advised \_\_\_\_\_ that she had just served an underage decoy. \_\_\_\_\_ advised me that server Albor-Mata had greeted decoy \_\_\_\_\_ for her. He then returned and told her that decoy \_\_\_\_\_ wanted a bottle of Bud Light. At 1838, \_\_\_\_\_ went to the bar and got a 12oz. bottle of Bud Light (see attached copy of receipt). \_\_\_\_\_ then served the bottle of Bud Light to decoy \_\_\_\_\_ then walked back to the food preparation area. Since \_\_\_\_\_ looked "so young" she made contact with Albor-Mata. She asked Albor-Mata, "Did you ID her?" Albor-Mata responded, "Yes". She then said, "You swear?". Albor-Mata responded, "yes". At this time I made contact with \_\_\_\_\_ and Albor-Mata.

I spoke to Albor-Mata who told me that he greeted decoy \_\_\_\_\_ for \_\_\_\_\_. He asked her what she wanted to drink and she said a Bud-Light. Albor-Mata told me that he did not ask her for ID or ask her age. He went back and told \_\_\_\_\_ that she ordered a Bud Light. After \_\_\_\_\_ delivered it he said that she asked him if he had ID'd her. He said that he told her that he had ID'd her. He said that I made contact with them right after they had this conversation. Albor-Mata completed a written statement (see attached).

I advised restaurant manager Jamie Benner and advised her of this incident. Ofc. Galich issued Albor-Mata citation 705624 for failing to inquire age. I took possession of the 12 oz bottle of Bud Light and the receipt for this beer. Ofc. Galich later tagged these items into evidence.
