The bartender, Erik Bialkowski, asked _____ or his identification. _____ advised Bialkowski that it was in his vehicle. _____ further advised Bialkowski that he would get his ID from his vehicle. Bialkowski told _____ not to worry about it. Bialkowski returned with a glass of Sam Adams and served it to _____. _____ proceeded to walk out to me and informed me that he was served. I also observed the sale take place.

I spoke with Bonnie Bates, California Pizza Kitchen manager. I explained the situation to Bates and advised her what would be required of the business. I issued a citation to Bialkowski for "Fail to Inquire as to age." (citation #710336) I gathered the required information to complete an L.C.C. violation report. The glass of Samuel Adams Boston Lager was retained by California Pizza Kitchen.
