2007 Class C license with Sunday Sales Permit, in escrow.

Section 501(2) of the Michigan Liquor Control Code of 1998, being MCL 436.1501(2) provides in pertinent part as follows... "An application for a license to sell alcoholic liquor for consumption on the premises, except in a city having a population of 750,000 or more, shall be approved by the local legislative body in which the applicant's place of business is located before the license is granted by the commission, except that in the case of any application for renewal of an existing license, if an objection to a renewal has not been filed with the commission by the local legislative body not less than 30 days before the date of expiration of the license, the approval of the local legislative body shall not be required. . ."

The Commission finds that a certified copy of the March 17, 2008 Resolution of the Troy City Council objecting to the renewal of the subject Class C license, was filed with the Commission March 26, 2008.

THE COMMISSION FINDS THAT THE CITY OF TROY HAS, BY RESOLUTION, AFTER DUE NOTICE AND PROPER HEARINGS, OBJECTED TO THE RENEWAL OF THE CLASS C LICENSE ISSUED TO LA SHISH, INC., LOCATED AT 3720 ROCHESTER, TROY, OAKLAND COUNTY, FOR THE 2008-2009 LICENSING YEAR; THEREFORE, IT IS THE ORDER OF THE COMMISSION THAT PURSUANT TO SECTION 501(2) OF THE MICHIGAN LIQUOR CONTROL CODE OF 1998, BEING MCL 436.1501(2), A RECOMMENDATION OF APPROVAL MUST BE OBTAINED FROM THE TROY CITY COUNCIL BEFORE THE CLASS C LICENSE MAY BE ISSUED.
