<p>12-37633</p> <p>On 11/13/2012 Directed Patrol Unit Officers (DPU) STOPCZYNSKI, JULIAN, and RACZKA were conducting Liquor Control Commission (LCC) checks with minor decoy [REDACTED]. [REDACTED] identification was held for safekeeping by the TROY POLICE DEPARTMENT during the LCC checks.</p> <p>At approx 1830 hrs, decoy [REDACTED] entered the CAMP TICONDEROGA restaurant at 5725 Rochester Rd. Upon entering the restaurant, [REDACTED] sat at the bar and asked the bartender (young, w/f) for a glass of Chardonnay wine.</p> <p>The bartender did not ask [REDACTED] for her identification or inquire about her birthdate and proceeded to pour the glass of wine.</p> <p>Once the wine glass was placed in front of her, [REDACTED] contacted PO JULIAN and advised him of the violation. PO STOPCZYNSKI and RACZKA soon entered the restaurant, made contact with the general manager, TANYA COUDRET and the bartender, LINDSAY MEISNITZER, and advised them both of the sale of liquor to a minor, and violation of the Michigan Liquor Control Commission.</p> <p>MEISNITZER was informed of the civil infraction she committed and was issued citation #725633 for "furnishing/sale to a person under 21/fail to inquire age".</p>


