 SUBJECT: Liquor Violation Hearing – National Coney Island

This matter was scheduled for a liquor hearing on February 20, 2013. At that time, Kelly Allen, the attorney representing National Coney Island, appeared and notified City Council that her client was mistaken as to the actual date of the hearing, and was unfortunately out of state on February 20, 2013. On behalf of her client, Ms. Allen acknowledged that there was a liquor license violation at National Coney Island, located at 3364 Rochester Road, Troy, on November 13, 2012. On that date, an underage minor decoy was served a glass of white zinfandel wine. The person who served the wine to the minor pled responsible to the charge of selling alcohol to a minor, and she paid a fine of \$100 on November 30, 2012. The Michigan Liquor Control Commission (MLCC) has not yet adjudicated this matter.

National Coney Island has a Class C resort liquor license, which means alcohol is served to patrons for consumption on the premises. Under MCL 436.1501, on premises liquor licenses are automatically renewed on a yearly basis unless the local legislative body (City Council) objects on or before March 31 of each year. A liquor license violation, such as the sale of alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license. Through the scheduling of liquor hearings, the Troy City Council is empowered to review liquor license infractions at licensed establishments. These reviews are held prior to March 31 of each year, which provides City Council with the opportunity to review each violation, as well as the record of each licensee, to determine whether or not to object to the otherwise automatic renewal of an on-premises liquor license. If a violation is not contested, the scheduled hearing provides the licensee with an opportunity to provide any extenuating circumstances surrounding the violation, or to tell Council about proactive measures taken to minimize the risk of future violations. In past years and when supported by the record, licensed establishments have agreed to take certain actions in consideration of Council's willingness to forego an objection to the automatic renewal of the on premises liquor license. These actions include but are not limited to the requirement for all serving employees to submit to training (TIPS/TAMS training or an equivalent); the exploration and/or implementation of new software designed to minimize sales to minors; participation in programs sponsored by the Troy Community Coalition (such as Project Sticker Shock); and participation in voluntary internal or external sting operations.

Proposed resolutions are prepared for your consideration. The first resolution, Proposed Resolution A, requires the licensee to complete server training. The second resolution, Proposed Resolution B, objects to the automatic renewal of the on premises liquor license, which would require the license to be placed in escrow as of April 1, 2013.

| <p>On 11/13/2012 Directed Patrol Unit Officers (DPU) STOPCZYNSKI, JULIAN, and RACZKA were conducting Liquor Control Commission (LCC) checks with minor decoy, [Redacted]. [Redacted] identification was held for safekeeping by the TROY POLICE DEPARTMENT during the LCC checks.</p> <p>At approx 1735 hrs, decoy [Redacted] entered the NATIONAL CONEY ISLAND restaurant at 3364 Rochester Rd. Upon entering the restaurant, [Redacted] sat at the counter and asked the server (w/f, blonde hair) for a glass of White Zinfandel wine.</p> <p>The server asked [Redacted] for her identification, prompting [Redacted] to reply that she left it in the car. The server stated that it was okay and asked what year [Redacted] birthday was in. [Redacted] replied 1993 (which equals 19 years old), and the server still proceeded to pour the glass of wine.</p> <p>Once the wine glass was placed in front of her, [Redacted] contacted PO JULIAN and advised him of the violation. PO STOPCZYNSKI and RACZKA soon entered the restaurant, made contact with the assistant manager, KEVIN FOUCHHEY and the server, HEATHER HESSE, and advised them both of the sale of liquor to a minor, and violation of the Michigan Liquor Control</p> | |

HESSE was informed of the civil infraction she committed and was issued citation #725631 for "furnishing/sale to a person under 21/fail to inquire age".

LCC violation form was completed and submitted. Officers retained the sales receipt of \$3.17 and tagged it on evidence. Violation report to be submitted to LCC.




