Subject: Private Agreement – Contract for Installation of Municipal Improvements
Galleria of Troy - Project No. 13.904.3

History

The Galleria of Troy proposed by Galleria of Troy, LLC is located at the north west corner of Big Beaver and I-75 in section 21.

Troy Planning Commission recommended preliminary site plan approval on March 12, 2013, resolution #PC-2013-03-018.

Site grading and utility plans for this development were reviewed and recently approved by the Engineering Department. The plans include municipal improvements; Water Main, Sanitary sewer, Storm sewer, Paving, Sidewalks, Soil erosion and Landscaping, which will be constructed by Galleria of Troy, LLC on behalf of the City of Troy. The required fees and refundable escrow deposits in the form of Performance Bond and 10% Cash, that will assure completion of the municipal improvements, have been provided by Galleria of Troy, LLC (see attached Private Agreement).

This Contract, made and entered into this 17th day of June, 2013 by and between the City of Troy, a Michigan Municipal Corporation of the County of Oakland, Michigan, hereinafter referred to as "City" and Galleria of Troy, LLC whose address is 30500 Northwestern Hwy., Suite 525, Farmington Hills, MI 48334 and whose telephone number is 248-855-2100 hereinafter referred to as "Owners", provides as follows:

FIRST: That the City agrees to permit the installation of Water Main, Sanitary sewer, Storm sewer, Paving, Sidewalks, Soil erosion and Landscaping in accordance with plans prepared by Professional Engineering Associates whose address is 2430 Rochester Ct., Sute 100, Troy, MI 48083 and whose telephone number is 248-689-9090 and approved prior to construction by the City in accordance with City of Troy specifications.

SECOND: That the Owners agree to provide the following securities to the City prior to the start of construction, in accordance with the Detailed Summary of Required Deposits & Fees (attached hereto and incorporated herein):

Refundable escrow deposit equal to the estimated construction cost of \$ 525,656.00. This amount will be deposited with the City in the form of (check one):

Said refundable escrow deposits shall be disbursed to the Owners after approval by the City. The City reserves the right to retain a minimum of ten (10) percent for each escrowed item until the entire site/development has received final inspection and final approval by all City departments. Refundable cash deposits shall be held until final approval has been issued. Disbursements shall be made by the City within a reasonable time, after request for refund of deposits is made by the Owners.

THIRD: The owners shall contract for construction of said improvement with a qualified contractor. Owners, or their agents, and contractor(s) agree to arrange for a pre-construction meeting with the City Engineer prior to start of work. All municipal improvements must be completely staked in the field under the direct supervision of a registered civil engineer or registered land surveyor, in accordance with the approved plans. Revisions to approved plans required by unexpected or unknown conflicts in the field shall be made as directed by the City.

FOURTH: Owners agree that if, for any reason, the total cost of completion of such improvements shall exceed the sums detailed in Paragraph SECOND hereof, that Owners will immediately, upon notification by the City, remit such additional amounts in accordance with Paragraph SECOND hereof. In the event the total cost of completion shall be less than the sums as detailed in Paragraph SECOND hereof, City will refund to the Owners the excess funds remaining after disbursement of funds.

FIFTH: Owners agree to indemnify and save harmless City, their agents and employees, from and against all loss or expense (including costs and attorneys' fees) by reason of liability imposed by law upon the City, its agents and employees for damages because of bodily injury, including death, at any time resulting therefrom sustained by any person or persons or on account of damage to property, including work, provided such injury to persons or damage to property is due or claimed to be due to negligence of the Owner, his contractor, or subcontractors, employees or agents, Owner further agrees to obtain and convey to the City all necessary easements and/or right-of-way for such public utilities as required by the City Engineer.




