

I, Sgt. Schaufler, along with Student Enforcement Aide \_\_\_\_\_ went to 7-11 Store at 1650 Crooks Rd. in Troy to conduct an LCC inspection. \_\_\_\_\_ had no identification with him as it was held at the Troy Police Department. \_\_\_\_\_ activated a small personal tape recorder and gave a brief introduction indicating the time, date, and location. \_\_\_\_\_ then entered the business, selected a six pack of Bud Light beer and proceeded to the checkout register. The sales clerk, later identified as Markita Nicole Jarrett, initially asked \_\_\_\_\_ if he was old enough to purchase the alcohol. \_\_\_\_\_ stated he was 22 years old. Cashier Jarrett then requested identification from \_\_\_\_\_. He replied he did not have his ID on him. Cashier Jarrett then rang up the sale of the Bud Light beer for a total of \$6.74. \_\_\_\_\_ paid for the beer and exited the store carrying the Bud Light, which he handed over to me. I entered the 7-11 Store and made contact with sales clerk Jarrett. I obtained the required liquor license information and completed a LCC Violation Report. I issued Ms. Jarrett citation # 710342 for furnishing alcohol to a minor. The Bud Light beer and audiotape were tagged and placed into evidence (tag#144532). No further action taken.
