SUBJECT: Liquor Violation Hearing- The American Legion Charles Edward Post 14

---

On May 7, 2009, the Troy Police Department conducted underage decoy inspections for liquor licensed establishments in the City of Troy. The team went to the American Legion, at 1340 W. Maple Road, where the underage minor decoy was served a bottle of beer. The person who served the beer to the minor has pled responsible to the charge of *selling alcohol to a person under 21 years of age*, and was fined \$100 on May 13, 2009.

The American Legion did not contest the violation before the Michigan Liquor Control Commission (MLCC), and on June 25, 2009, the licensee was required to pay a fine of \$800 or have a 40 day suspension of sales of liquor.

The American Legion has an "on-premises" (club) liquor license, since alcohol is served to patrons for consumption on the premises. Under MCL 436.1501, on premises liquor licenses are automatically renewed on a yearly basis unless the local legislative body (City Council) objects on or before March 31 of each year. A liquor license violation, such as the sale of alcohol to a minor, could serve as a basis for objecting to the automatic renewal of the liquor license, as the possession of an on-premises club license is a privilege. However, since the club has made an investment upon the initial grant of the liquor license, each licensee is entitled to a due process hearing, to provide the licensee an opportunity to challenge the violation. In the due process hearing, the City has the obligation to prove that there was a violation. The liquor violation hearing is scheduled in advance, with notice sent by certified mail to the licensee.

Pursuant to a phone call with Bob Lehman on behalf of The American Legion, it is my understanding that the American Legion is not contesting the violation occurred, and will waive the due process hearing. This fact should be confirmed by the Mayor prior to opening the hearing. If the hearing is officially waived by the licensee, then I will make a brief recitation of the facts of the violation, and will also rely on the redacted police incident report and the licensee's record, which are attached to this memo and will be part of the record. After that time, City Council may have questions for the licensee or City Administration.

A resolution confirming the liquor license violation, and requiring additional training for all of the licensee employees that serve alcohol is proposed for your consideration. If City Council is concerned about the past record of the licensee, or is concerned that the licensee has not taken sufficient precautionary measures to protect against future sales of liquor to minors, then City Council can also pass a resolution objecting to the automatic renewal of the on-premises liquor license, which would be effective as of May 1 (the start of the new license year).



Report Narrative **09-14222**

On listed date and time, DPU Officers, Minton and Galich, were performing LCC inspections with minor decoy, . Officers transported [redacted] to the American Legion at 1340 W Maple Rd.

[redacted] went to the bar and asked the W/F bartender, later identified as Donna Brimm, for a Budweiser bottle. Brimm asked [redacted] for his identification and he stated that he did not have it on him. A patron sitting next to [redacted] at the bar told Brimm that he would sponsor. Brimm said okay and served [redacted] a bottle of Budweiser beer. [redacted] then called PO Minton on the telephone and advised that he had been served (see [redacted]'s attached statement).

PO Minton and PO Galich entered the American Legion and advised Brimm that she had served a minor. Officers obtained the LLC license for the establishment and Brimm's identification. Brimm was issued citation 738676 for furnish or sell alcohol to a person under 21. The LCC violation form was also completed.


