• **Review June 30, 2018 RHC Audited Financial Statements**

- Administrator Darling reviewed excerpts of the City's Comprehensive Annual Financial Report (CAFR) for the year ended June 30, 2018 that related to the Retiree Healthcare Benefits Plan & Trust.
- He noted that the system generated \$11,365,217 of additions through

contributions and investment income and expended \$5,610,586 of deductions through benefit payments and administrative expenses resulting in a change in net position of \$5,754,631.

- Total Net Position at the end of the Fiscal Year was \$83,149,083. Of this amount, \$81,337,626 is restricted for Retiree Healthcare Trust Fund and \$1,811,457 is restricted for retiree healthcare pension system.
- Administrator Darling also noted that currently we are 59.45% funded.
