Subject: Standard Purchasing Resolution 4: Award – Oakland County and MiDeal Cooperative Purchasing Agreements – Fleet Vehicles

History

- The seven (7) vehicles being purchased are planned replacement vehicles for the Police Department.
- The seven (7) obsolete vehicles will be removed from service and sold at auction with estimated proceeds of \$40,000.00.
- This purchase replaces existing vehicles and does not increase the size of the existing Department of Public Works motor pool fleet.

Purchasing

- Galeana’s Van Dyke Dodge of Warren, MI is the low total bidder in the Oakland County Cooperative Bid. The Oakland County Contract (ID # 004931) contract pricing is valid thru 2019 model year Dodge vehicles.
- *Gorno Ford of Woodhaven, MI* is the total low bidder in the State of Michigan Cooperative Bid. The MiDeal Contract (ID # 071B7700181) contract pricing is valid thru 2020 model year Ford vehicles.
- On February 10, 2014 City Council authorized departments to utilize sites such as GovDeals.com to dispose of city owned surplus items (Resolution# 2014-02-017-J-4a). Therefore note that the city will utilize and market the seven (7) obsolete vehicles on GovDeals.com site for optimal trade-in value.

- Funds in the amount of \$224,000.00 are available in the Public Works Fleet Division Capital Account Project # 2020C0081.
