Subject: Standard Purchasing Resolution 4: Award – Oakland County Cooperative Purchasing Agreement – Fleet Vehicles

History

- The four (4) vehicles being purchased are replacement vehicles for the Police Department.
- Four (4) replacement detective vehicles.
- The four (4) obsolete vehicles will be removed from service and sold at auction with estimated proceeds of \$20,000.00.
- This purchase replaces existing vehicles and does not increase the size of the existing Department of Public Works motor pool fleet.

Purchasing

- *Berger Chevrolet of Grand Rapids, Michigan* is the low total bidder in the Oakland County Cooperative Bid. The Oakland County Contract ID #005218 pricing is valid thru September 30, 2019 on selected Chevrolet vehicles.
- *Todd Wenzel Buick GMC of Westland, Michigan* is the low total bidder in the Oakland County Cooperative Bid. The Oakland County Contract ID #005222 pricing is valid thru September 30, 2019 on selected GMC vehicles.
- On February 10, 2014 City Council authorized departments to utilize sites such as GovDeals.com to dispose of city owned surplus items (Resolution# 2014-02-017-J-4a). Therefore note that the city will utilize and market the four (4) obsolete vehicles on GovDeals.com site for optimal trade-in value.
